5. Presentation of the UnBound FY16 Report by the Meridian Library District [Nick Grove]

Nick Grove presented the FY16 report for unBound. He reviewed the usage numbers and by whom and the goals for FY17. He reviewed the programming for unbound and their ongoing communication strategies. Board members expressed their excitement and acknowledgement of the good work by Meridian Library District.

6. Presentation of the Meridian Youth Farmer's Market and FY17 Sponsorship Request [Becky Breshears]

Becky presented the history of the market. She stated there were 38 vendors [32 of which were youth]. It is her goal to find another produce vendor or two. She stated how children grew over the summer with their businesses. The market ran June through September but after Labor Day the traffic died. She expressed that publicity is the key moving forward. Commissioner Basalone expressed concern regarding the enrollment process. Becky stated she is working on streamlining. She stated that vendors are not required to be there every week and can pick which weeks work for their schedules. Becky stated she is requesting \$5,000 from MDC. She is training someone to take over the week to week management so her involvement is more on the back end. She would like to obtain additional signage as the largest challenge is getting people downtown. Commissioner Winder stated he would like to see more adult vendors and appreciated the weeks when live music and the bookmobile were present. Administrator Squyres explained the next steps in the process, which included coming back to the board with a formal agreement. A motion was made by Commissioner de Weerd and seconded by Commissioner Basalone to direct staff to come back with an agreement with Becky Breshears in the amount of \$5,000 in unrestricted funds, de Weerd further stated she would like Becky to come back in March and April with updates.
