#### 6. Legislative Update [Scott Turlington]

Scott was unable to attend the meeting. Squyres updated the board on the potential bills that anticipate receiving a print hearing in the near future.

### 7. Meridian Historic Preservation Commission presentation and discussion pertaining to potential preservation overlay zones within the City of Meridian, including downtown [Historic Preservation Commission]

Josh Evarts presented on behalf of the MHPC. He wanted to begin a discussion as to the potential creation of a neighborhood conservation overlay district to preserve existing older areas within a community. Two areas have been identified: Main Street north of Carlton and Pine Avenue. There have not been any discussions thus far with the property owners as the HPC is only researching at this time. Commissioner de Weerd asked Josh to speak with planning to put together a community involvement plan but stated she may be worried it is already too late. Josh agreed. He also provided a quick update as to other HPC pursuits: interior/exterior photos of key homes, created virtual tours of two properties, creation of a calendar of historic barns, historical walking tour app, and children's museum sponsored barn exhibit.

## 8. Consideration of approval of the PC Maintenance bid for the repair, the resealing, and the striping of the Masonic Temple parking lot and Corresponding Resolution 19-011 [Squyres/Lakey]

Squyres and Counsel Lakey reviewed the bid. Squyres stated the Mason's have asked for the "spider cracks" to be fixed as well. Squyres stated this will come within a separate bid. Squyres also mentioned the Mason's may wish to amend the agreement to include dedicated parking for the Mason's 24/7 but is awaiting further information. A motion was made by Commissioner Bevan and seconded by Commissioner McCarvel to approve the bid and to grant Squyres the authority to approve the subsequent bid as long as it is below \$2500.
