# 5. Consideration of the contract addendum for Primus MG for legislative services during the 2020 interim property tax committee and corresponding resolution 20-011 (Squyres/Lakey)

Squyres stated that the scope of work is based on the conversation held at the prior MDC board meeting. The scope allows Primus to represent MDC at the interim property committee beginning this summer. The scope will expire at the end of 2020 or when the interim committee concludes. The monthly fee of \$2,500 remains consistent with the other service agreements with Primus.

David Lehman of Primus stated that the legislative council will be appointing the interim committee next Friday, June 05th. He stated that Senator Rice is targeting URAs through this committee.

Counsel Lakey confirmed the June 05<sup>th</sup> selection date and the fact that the committee anticipates meeting through the end of November.

A motion was made by Commissioner Basalone and seconded by Commissioner McCarvel to approve the \$2,500 per month contract addendum for Primus MG.

# 6. Consideration of approval of the façade improvement grant reimbursement for 126/128 South Broadway Avenue (Squyres/Lakey)

Squyres informed the board that the work on 126 and 128 South Broadway Avenue has been completed and a reimbursement request in the formerly approved amount of \$26,291.09. In the board packet Squyres has provided: photos of the completed work; an email from the owner detailing the costs; copies of the invoices and receipts; the original application by the owner and the subreceipient agreement for the board's review. She stated the reimbursement request was reviewed by herself, legal counsel, and the accounting firm.

Commissioner de Weerd offered her positive thoughts on the project and the process and its impact on downtown Meridian.

A motion was made by Commissioner Mueller and seconded by Commissioner de Weerd to approve the façade improvement grant reimbursement in the amount of \$26,291.09.

# 7. Consideration of approval of the Memorandum of Agreement with the City of Meridian for FY2020 Concerts on Broadway partnership and corresponding resolution 20-012 (Squyres/Lakey)

Squyres stated that while MDC placed \$10,000 in the FY20 budget, there's been no formal request until now to solidify this into an agreement. Audrey Belnap from the Arts Commission is requesting that we finalize the MOA for the Summer 2020 season now that a decision has been made to move forward with the series.

Audrey Belnap introduced herself. It is the intention of MAC to move cautiously forward with the Concerts on Broadway series on the following dates: August 29, September 12, and September 26. She stated they will be addressing any COVID-related issues.

Counsel Lakey reviewed the finer points of the agreement with the board.

A motion was made by Commissioner Bevan and seconded by Commissioner Bernt to approve the MOA for Concerts on Broadway in the amount of \$10,000.

The weekly update notes for the Civic Block are included in the board packets. There will be a joint MDC and City Council meeting on July 21<sup>st</sup> in order for the staff and the developer to provide a project update.
